- Anyone who is feeling under the weather should stay home
- Anyone who enters the rink is required to wear a face covering & must wear the mask while on the ice
- The group lessons cost includes a 30-minute class & 30-minute practice (PLEASE CHECK THE SCHEDULE BELOW FOR PRACTICE TIMES)
- All skaters are required to display their lessons program identification (ID) tag while on the ice
- All skaters are required to have a MANDATORY ISI membership and is required for both group and private skaters. The costs are \$15.00 & registered online @ skateisi.org (We also accept US Figure skating memberships)
- No make-up classes or refunds
- NO SPECTATORS ARE ALLOWED IN THE BUILDING OR BLEACHERS! Parents or guardians are allowed in the building to help their children put their skates on but must wait in their car while their skaters are taking their lesson or practice session. Skaters & parents can enter the building 10 minutes before the start of lessons or practice & are required to leave the building 10 minutes after their lesson or practice has finished.
